

Wags Daycare for Dogs, LLC

*This agreement shall be in force from the date signed and for all visits thereafter to
Wags Daycare for Dogs LLC hereafter referred to as 'WDFD'.*

I, _____, hereby certify that my dog(s): _____ is/are in good health and have not been ill with any communicable diseases in the last 30 days; and that my dog(s) has/have current vaccinations for rabies, distemper, parvovirus, parainfluenza, hepatitis (adenovirus) and bordetella. Dogs arriving with fleas and/or ticks may be treated with Advantage® II or Advantix ® II at WDFD's discretion, at my expense. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog, except as disclosed under part 6 (a) and (b) of this agreement. I give authorization to WDFD to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status, date of surgical alteration, and medical history.

I have read and understand the following:

1. WDFD is an open play environment and because of this there are inherent risks, which even when closely monitored, may result in the following: i) transfer of communicable illness such as, but not limited to, bordetella virus ("kennel cough"), and ii) superficial injuries such as, but not limited to, broken nails, sore pads, minor abrasions and/or cuts. The owner of the dog agrees to take full responsibility for taking precautions against contagious illness and parasite exposure by consulting their own veterinarian, and accepts all reasonable risks of injury incurred in normal daycare activity.
2. WDFD and their staff shall not be liable for any injury or damage to any person or persons, animals, or to any property, however caused, which result from the behavior or care of my pet, as well as from any negligence on the part of any other pet owner attending WDFD. I further agree that WDFD shall not be liable for any costs, attorney's fees or expenses incurred in connection with any claim, action or proceeding occurring as a result of my pet's participation at WDFD.
3. WDFD reserves the right to administer aid and/or use any available veterinarian for my pet should the need arise, whether or not WDFD can reach me or my emergency contact. I assume full financial responsibility for any and all veterinary expenses incurred, in addition to other fees incurred for services provided at or by WDFD.
4. I agree to pay the rate for services in effect on the date my dog(s) attend(s) WDFD. Prices are subject to change at any time. No dog will be released until all charges are paid in full. Cancellation fees may be applied for reservations cancelled less than 24 hours prior to a scheduled reservation.
5. I am solely responsible for any harm and/or damage caused by my dog(s) to persons, property or other pets, while my dog(s) is/are attending WDFD. WDFD reserves the right to refuse services or admittance to any dog. Costs for repairs to property will be my sole responsibility.
6. I understand that the hours of operation are by appointment only from 7am to 6pm, closed from 12pm to 2pm, Monday through Friday. Saturday hours are from 9am-11am and 3pm-5pm. Sunday hours are from 4pm-6pm. I agree to pay the \$5.00 late fee (starting at 6:01pm) for every 10 minutes that I am late to pick up my dog(s). I understand that my dog may be boarded for the night if late pickup is not available that evening and will assume all additional boarding costs.
7. Should I or my pre-approved agent fail to contact WDFD within 24 hours of the arranged pick up time, my pet will be considered to be abandoned. Any expenses incurred for the transport, overnight care, and/or placement or adoption of said pet shall be paid by me in addition to other fees incurred for services provided by, at, or through WDFD. I hereby grant a lien on said pet for any and all unpaid charges resulting from services provided by, at, or through WDFD.
8. I understand that although the owner of WDFD lives onsite and gives boarding dogs their late evening potty break, WDFD is only officially 'staffed' during office hours.
9. I agree that my pet(s) may be videotaped, photographed, and/or recorded. WDFD shall retain the exclusive rights to the results and all proceeds of such tapings, photograph, and recordings with the rights throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner.
